requested by the relevant municipalities in order to promote them. All the works for the installation of the charging facilities or related to the stationing of the vehicle should be executed by licensed subjects in accordance with the Albanian Law.

July 2016 as revised ("Procurement Regulations"), and is open to all Bidders as defined in the Procurement Regulations. The signing of the contract would be subject to extension of the Additional Financing.

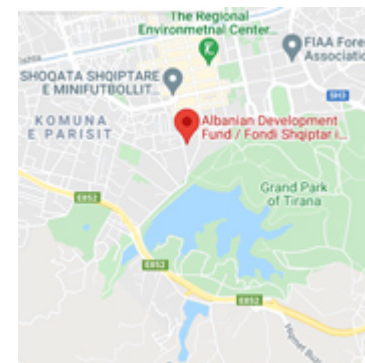
